The Faculty Council of the Veterinary Faculty of the University of Zagreb, pursuant to Article 40 of the Statute of the Veterinary Faculty of the University of Zagreb, following a proposal by the Committee for Integrated Undergraduate and Graduate Studies, at its 4th regular session held in electronic form on 25th January 2023, rendered the following:

DECISION

Regarding the amount of tuition fees, reservation of places for study, the amount of the registration fee for the undergraduate and graduate university studies of veterinary medicine in English, the obligations of students during the suspension of their study year, and the costs of the physics course for the 2023/2024 academic year

- a) the annual tuition fees for the 2023/2024 academic year shall be 9,000,00 EUR (67,810.50 HRK)
- b) the annual tuition fees may be paid in two instalments, before the beginning of classes in each semester, each in the amount of 4,600 EUR (34,658.70 HRK) For students from Libanon the tuition fee can be paid in four consecutively monthly instalments (Due to local Libanon law-not possible to make monthly money transfers larger then 2500 eur.).
- c) the fee for reservation of a study place shall be 500 EUR (3,767.25 HRK) for students who have been sent an acceptance letter in the enrolment process. Payment of the reservation is valid until 14th July 2023. If the candidate decides to accept the place on the course within the given time limit, the annual tuition fees will be reduced by the amount of the reservation. If the candidate withdraws, the amount of the reservation shall not be returned to the payer.
- d) the registration fee for enrolment in the study programme in veterinary medicine in English for the 2023/2024 academic year amounts to 50 EUR (376,72 HRK). This must be paid by all candidates for the processing of each individual application.
- e) the annual tuition fee for students who meet the requirements for partial enrolment is 4500 EUR (33,905.25 HRK).

f) In the case of a student transfer to the Veterinary Faculty of Veterinary Medicine of the University of Zagreb that has been approved by a Decision of the Committee for Academic Recognition of Foreign Higher Education Qualifications of the University of Zagreb, upon enrolment at the Veterinary Faculty, as the entrance into the system, the student must pay the full amount of the tuition fee in the amount of 9,000 EUR (67,810.50 HRK) regardless whether the transfer is for full or partial enrolment in the study year according to the Decision by the Committee for Academic Recognition.

g) In the case of the suspension of studies that has been approved by the Faculty, the student is not obliged to pay tuition fees, but for every examination taken a payment of 300 EUR (2.260.35 HRK) is due.

h) The fee for the physics course that is part of the veterinary medicine study programme in English for the 2023/2024 academic year is 500 EUR (3.767,25 HRK) per student, and for the Croatian language course 500 EUR (3.767,25 HRK) per student.
